 - a. Roy is the coordinator for the Compeer Program at MHA
 - i. Volunteers from the community are connected with individuals in recovery from mental health and are homebound. These volunteers provide companionship and support.
 - ii. Roy also started Compeer CORPS, a Compeer program for veterans. This program includes "Veterans Night Out" which is an activity done together in the community. These happen at least seven times a year.
 - iii. There are currently 57 people who have been connected with 52 Compeers.

- b. Butler County Prevention Council- Met with county on more information on the need for foster care and how to reach out and acquire more foster parents.
- c. Early Care and Education Council- On June 1st Butler County started to become part of a PA early literacy team. There were breakout sessions on Kindergarten transition and early literacy. Also, they have continued to work on helping families of young children with addressing behavioral issues. The goal is to also assist these families with navigating the system.
- d. Local Housing Options Team- No update
